# TERMS AND CONDITIONS OF ENROLLMENT

## STARTING YOUR BUSINESS

Registration to open your Vitamark affiliate account is \$29.00. With this you will receive your starter kit, personalized website, Group Management Tool (GMT).

## ACCEPTED METHODS OF PAYMENT

1. Vitamark International™ may withdraw funds from your Checking Account, Visa, MasterCard, American Express, Discover/NOVUS, in the amount you have authorized.
2. Vitamark International™ cannot obtain more funds from your account than those you have authorized.
3. Vitamark International™ will charge actual shipping plus a \$2.00 processing/handling fee for all product transactions.
4. If your credit card or ACH (Automatic Withdrawal) does not clear you will not receive your products.

## WEEKLY BONUS CHECK

1. I understand that the weekly bonus checks will be mailed each Tuesday.
2. I further understand that, if my bonus check is less than \$25.00, it will be accumulated with future bonuses until the \$25 minimum is reached.

## GENERAL POLICIES

1. As a Vitamark affiliate, I acknowledge that I am an independent contractor and not an agent or employee of Vitamark International. I understand that I will not be treated as an employee for Federal or state tax purposes. I agree to abide by all policies and procedures as outlined in Vitamark literature such as the Policy Guide.
2. As a Vitamark affiliate, I will make no statements, disclosures, or representations to sell Vitamark products or services, or in recruiting other prospective affiliates, other than those contained on the Vitamark website or in approved literature.
3. I understand that no purchase other than the registration fee is necessary to open a Vitamark affiliate account. I understand that I may close my account at any time. I further understand that I am under no obligation to make any financial investment to become a Vitamark affiliate. I also understand that any successful retail business will incur business expenses beyond the purchase of product.
4. I understand that to become a Silver affiliate and be eligible to earn bonuses, I must generate a minimum of 50 BP/QP within a single calendar week. Once I am eligible to earn bonuses, I must maintain the weekly qualifications in order to earn Vitamark bonuses. For an explanation of BP/QP, see the Compensation (vOS) brochure.
5. Vitamark bonuses are paid on a weekly basis, so I understand that to earn bonuses I must not only meet the weekly qualifications for each bonus level, but must maintain one of the following qualifications: (1) Generate a minimum of 50 BP in AutoShip orders in the last four weeks this includes the current week and the prior three weeks;

or (2) Generate 100 BP in orders in the current bonus qualification week.

6. I understand that if I go twelve weeks without generating orders totaling 100 BP/QP, I will return to the personal group of my sponsor and will not be able to earn bonuses until I re-qualify at the Silver level or above. I also understand that any personal enrollees in my bonus organization or personal group will roll up to my sponsor. I understand that when I regain my bonus status, I will not regain the enrollment credit of any personal enrollees who have rolled up to my sponsor.
7. I understand that in order to maintain a viable marketing system and to comply with changes in applicable laws, Vitamark International™ reserves the right to change prices, company policies, company literature and/or the Vitamark Operating System (vOS), without prior notice.
8. I understand that, should I wish to terminate my affiliate account, I must notify Vitamark International™. Within thirty (30) days after resignation, any salable product may be returned to Vitamark International™ for a refund equal to 90% of the original purchase price, less any commissions or bonuses paid. This refund is subject to my prior representations regarding compliance with the 70% product usage rule (see next paragraph). In any state in which a specific buy-back requirement has been enacted which may vary from the foregoing, Vitamark International™ shall re-purchase products in accordance with the applicable statute. Perishable items will not be refunded after 90 days from date of purchase.
9. I understand that in order for me to be successful in this program I must accumulate Group Bonus Points by the purchase and sale of Vitamark products and sponsor other affiliates to do the same. In order for the affiliates I sponsor to be successful they must accumulate Group Bonus Points by the purchase and sale of products at retail, and recruit other people to do the same, and so on. I understand that, in order to qualify for commissions, I must retail or personally use in business building at least 70% of the product I purchase before I can purchase more product.
10. When and if I qualify as a Silver affiliate, I agree and understand that reports referring to large earnings of successful Vitamark affiliates are neither necessarily typical nor representative of what individual Vitamark affiliates may earn. No one can be guaranteed success as a Vitamark affiliate and not all affiliates earn residual income. Furthermore, Vitamark does not recommend that any prospective affiliate leave current employment nor make any substantive product purchase until such time as their retail business from the sale of products generates steady and significant income.
